

THE REGULAR MEETING OF THE EAST DUBLIN MAYOR AND COUNCIL

December 12, 2016

The regular meeting of the East Dublin Mayor and Council was called to order by Mayor George H. Gornto.

Invocation was led by Councilman Tanner followed by pledge to the flag.

A motion was made by Councilman Jackson and seconded by Councilman Young to approve the minutes of the previous meeting. All voted in favor with none opposed.

A motion to approve the bills was made by Councilman Williams and seconded by Councilman Tanner. All voted in favor with none opposed.

City Administrator Larry Drew presented to the Mayor and Council the new alcohol license application for packaged beer and wine for Ghanshyam Patel for his business, Amba Food Mart, located at 514 Buckeye Road. After discussion, a motion to approve the new license was made by Councilman Jackson and seconded by Councilman Williams. All voted in favor with none opposed.
