THE REGULAR MEETING OF THE EAST DUBLIN MAYOR AND COUNCIL

December 14, 2020

The regular meeting of the East Dublin Mayor and Council was called to order by Mayor George Gornto.

Invocation was led by Councilman Brown followed by pledge to the flag.

A motion was made by Councilwoman Roberson and seconded by Councilman Sheppard to approve, as read, the minutes of the previous meeting. All voted in favor with none opposed.

A motion was made by Councilman Brown and seconded by Councilman Sheppard to approve the bills. All voted in favor with none opposed.

A motion was made by Councilman Williams and seconded by Councilman Brown to approve the financial statements. All voted in favor with none opposed.

A motion to amend the 2020-2021 budget to adjust the funds received for 2021 LMIG and funds received through the CARES Act on the revenue side and adjust the expenses to reflect the funds received for the 2021 LMIG, adjust the travel expense, and, to use the CARES Act funds to give the employees of East Dublin a cost of living raise. The motion was made by Councilman Tanner and seconded by Councilwoman Roberson. All voted in favor with none opposed. (See Attached Copy)

A motion was made by Councilman Sheppard and seconded by Councilman Brown to give the City full-time employees a 2% cost of living adjustment to be retroactive back to December 1, 2020. All voted in favor with none opposed.

A motion was made by Councilman Williams and seconded by Councilwoman Roberson to accept the bid from Courtware Government Software Solutions for new municipal court software for the Police Department. The motion also included approving the City to enter into contract with Courtware Government Software Solutions. All voted in favor with none opposed. (See Attached Copy)

A motion was made by Councilman Tanner and seconded by Councilman Brown to adopt the Municipal Court Resolution that authorizes the City of East Dublin to attach a \$20.00 administrative fee to each paid traffic violation to offset the fee that will be charged to the City by Courtware Government Software Solution. All voted in favor of the resolution with none opposed.

Ordinance # 2020-03 Recovery Residence was presented to the Mayor and Council. After discussion, a motion was made by Councilman Williams and seconded by Councilman Sheppard to adopt Ordinance #2020-03 Recovery Residence. All voted in favor with none opposed. (See Attached Copy)
